NORMAN SASSIE – WOOD CUTTING PERMIT

Noted that ADK First Nation now supports Norman Sassies' application for a Wood Cutting Permit.

NEW BUSINESS

LIQUOR RESTRICTIONS

VETS WITHOUT BORDERS

Vets Without Borders will provide services in Fort Liard from September 19 to 24, 2024. The council agreed to provide the necessary hotel rooms for the veterinarians.

APPLICATION FOR A WATER LICENCE

The Yukon Government (Energy, Mines, and Resources) advised the Council that they intend to apply to the MacKenzie Valley Land and Water Board for a Type A Land Use Permit in preparation for the decommissioning of Kotaneelee well L-38. They are requesting feedback from Council so that it can be incorporated into the Application. Council reviewed the letter and did not put forward any concerns.

WILDFIRE AND RIVERBANK EROSION

The Council reviewed a request from the NWTAC to support their application to the Capacity Development Partner Grants Program for a Collaborative Training and Partnerships project. This project aims to address riverbank erosion and advance wildfire preparedness.

The council supported this application, and a letter of support will be sent to the Federation of Canadian Municipalities.

FINANCIAL

FUNDING POLICIES

The council reviewed a letter from the Minister of Municipal and Community Affairs detailing MACA funding policies and providing funding for Fort Liard for 2024/2025.

The SAO made a PowerPoint presentation outlining the details of these policies and the required financial reports. The presentation also detailed all funds received last fiscal year and what funds are budgeted for 2024/25.
